Funds available upon request." This expense should be included in the Subcommittee's annual budget.  TO:  4. The RCM, RCM Alternate and all Subcommittee Chairpersons required to attend the RSC may be reimbursed up to two hundred and fifty dollars (\$250.00) for travel and hotel expenses for the RSC weekend. They may also request travel reimbursement at a rate of 60% of the federal mileage rate for RSC weekend attendance if they travel 86 miles or more each way. Funds available upon request. This expense should be included in the Subcommittee's annual budget.		
INTENT:	To separate hotel and travel reimbursement line items for interested members to attend the RSC in order to maintain full transparency of the RSC. Hotel accommodations are capped for \$250 for the weekend. Travel will now include mileage calculations and are not included in the \$250 cap.		
DEBATE:	The area has already been reimbursing travel and accommodations for RSC weekend. During the policy manual update, the mileage calculation was eliminated. This motion is to add the federal guideline back in and to separate and clarify the reimbursement rate and cap for hotel stay. The RSC is held every 2 months BUT this reimbursement is only requested 2-4 times per year based on the rotated meeting location.

#### 8. ELECTIONS & NOMINATIONS

Nominations for vacancies may be made during any month. All ASC elected officer nominees should be asked the following questions:

Additionally, all nominees for an area money handling position will be asked the following questions by the Policy Chair:

All nominees, even with only one nomination, must go back to the groups for a vote and brought back to the ASC for election. Answers to questions will be submitted in the area minutes when nominees are referred to Groups. All nominees are required to attend the ASC for elections in August. If a nominee is not present for elections, his/her nomination will be withdrawn. Voting is done by a show of hands: positions with only one (1) nomination require 2/3 majority; positions with two (2) require only a majority; refer to policy for procedures for handling three (3) or more nominees for the same position.

## RSC Report to ASC 2/16/2020

Greetings family my name is Deana, addict and alternate RCM for Gold Coast Area. I attended the RSC on 2/16/2020 where there were 8/17 groups in attendance which did not allow us to meet quorum preventing any new business from being handled which included the motions brought by our Area. The Bahamas Area reports they are having their convention on Nov 6, 7, & 8 2020. There are registration forms and flyers in the back for more information. The hotel has been secured on the beach walking distance from casino, all inclusive-3 meals a day, beach and water sports are included as well. Pre-registration forms in the back currently \$20, going up to \$35 <a href="https://www.nabahamas.org">www.nabahamas.org</a>, you can download registration forms on the website as well. Booking of rooms - \$ 157 per person per night, double or triple occupancy rates will go down a bit. Need to book through hotel directly. South Broward Area reported Swamp Recovery was a success. Our Regional Delegate reports they are having workshops in longwood and Deland on February 22, 23. voting-with-resources/. It will be online until April 16, 2020. The CAT (Conference Approval Track) deals mostly with budget and projects of WSC, what they are going to do what they are going to spend. The CAT assembly will be at the April RSC at 1:00 pm in Lake Mary, Homewood Suites 755 Currency Circle. The board has said they can't really discuss in detail pending litigation, and there isn't very much information available about those that filed it either.
