If a nominee is not present for elections, his/her nomination will be withdrawn. Voting is done by a show of hands: positions with only one (1) nomination require 2/3 majority; positions with two (2) require only a majority; refer to policy for procedures for handling three (3) or more nominees for the same position.

## JULY 2020 ASC Treasurer Report -

The forwarding balance from last month in our Suntrust Bank checking account was \$16,095.76. Expenses this month currently total \$5148.98. Last month we paid a month's rent to Extra Space Storage, not a year's rent. This was due to a miscommunication on the telephone as well as a mild-to-moderate brain freeze on my part. We should have paid for the year in advance, and now have done so. Any group may donate to the area via mailing a check/money order OR via Zelle as outlined in the area minutes. Please look at your email that included the minutes or look in the chat box if you need the address and/or my phone number. Income this month is \$224.00 from group donations. The literature sales total was \$850.00 for a total bank deposit of \$1074.00 The current bank balance is now \$12,020.78 Liberty Tax Services reported nothing came from the IRS in the last month to establish our

not-for-profit status. I will check back with them in August if I do not hear from them. Looking ahead to August and September, Sunbiz will need to be updated as soon as the admin committee members have been voted in. Once completed, the bank account at Suntrust will need to be updated with both additions and removals of trusted servants as signers. While drive-thru services are available, Suntrust

Bank's current social distancing policy at some branches (and perhaps all) requires making appointments to enter the bank.

I feel obliged to remind the Gold Coast area that a concerted effort was made to make the everything legal. Coordinating the correct people needed to go to the bank may be a bit challenging. This might include all those listed on Sunbiz as the new officers to meet at one of the bank branches at the same time.
