**The No Limits Group of Narcotics Anonymous Ad Hoc Literature Group
The Spiritual Principle of *Acceptance***

Acceptance usually refers to cases where a person experiences a situation or condition (often a negative or uncomfortable situation) without attempting to change it, protest or exit. Acceptance is a spiritual principal known throughout the world that helps individuals move from their will to God’s will. Acceptance is being okay with the outcome even if we don’t like it. Many of us experience acceptance as a peace in our hearts regardless of what’s going on around us in our lives.

We have come to understand that there are different levels of acceptance in Narcotics Anonymous. We often start out by accepting the fact that we have a disease and that we need help. Acceptance implies surrender to the program. If we want to continue on our recovery journey, we work the 12 steps and develop a relationship with a Higher Power. We begin to not only accept our disease, but a spiritual solution.

Our first act of acceptance may come when we admit we’re an addict for the first time. Shortly thereafter, we become aware that with faith and trust in a Higher Power, we can be restored to sanity. As we stay clean and experience challenges, we surrender to life on life’s terms. Not only do we learn to accept ourselves, we learn to accept others and our Higher Power’s will.

We may learn to accept people, places and things as they are, and merely change our reactions to them. A common struggle for recovering addicts is that we cannot keep another addict clean. We learn to accept our powerlessness over another addict’s recovery, or their relapse. It is very difficult to see an addict relapse, but acceptance allows us to understand and accept their process. We show our acceptance by working our own

program and praying for God's will, no matter how much we hurt, feel angry or want to "fix" someone. At times we may have to accept that being an example is the best we can do. Acceptance allows God's will to work instead of our own.

Before we came to NA, we were in a state of denial. Before we gain acceptance, we're often in denial and caught in the endless loop of our addiction. Admittance is the prerequisite to acceptance. Surrender and freedom are the results of acceptance. The war is over. Acceptance opens the door to new possibilities and hope for a better future. Acceptance is taking ownership for our own spiritual condition and our recovery. It's taking responsibility for who we are and what our needs are. Admittance is the beginning of our first step, but acceptance is vital to a full surrender. Once we admit, we can either go to resignation or to acceptance. There is a lot of freedom once we've gotten to acceptance. Acceptance allows us to relieve the pain of the past so we can live fully in the present.

Opinion:

The importance of acceptance in recovery cannot be overstated. It is quite literally the answer to all your problems. Truly seeking acceptance means one must change everything about the way you look at the world. This is a process and cannot be accomplished quickly. Most must work on acceptance every day, some with every breath. But if you put the same effort and energy into acceptance that you put into your addiction a true and lasting serenity will be your reward.

When in active addiction you avoided the facts about the damage you were doing to yourself and others. Denial and resentment became the lens through which you viewed the world. You seemed to be disturbed by everyone and everything. Nothing seemed to be as it should. So, you tried to control what you saw as chaos. Striving to remake the world with your own will or escaping the unpleasantness with your drug of choice.

The truth is that everything is as it should be in this moment. Accepting the true nature of the world is the necessary first step to meaningful recovery. That does not mean that nothing should change. Do you not pray for "the courage to

“We made direct amends to such people wherever possible, except when to do so would injure them or others.”

We accept that it was our actions that caused our negative attitude. Step Nine helps us with our guilt and helps others with their anger. Sometimes, the only amend we can make is to stay clean. We owe it to ourselves and to our loved ones. We are no longer making a mess in society as a result of our using. Sometimes the only way we can make amends is to contribute to society. Now, we are helping ourselves and other addicts to recover. This is a tremendous amend to the whole community.

This desire to make amends should be the primary motive for working the Ninth Step. Making amends isn't something we do simply because our program of recovery suggests it. To be certain our motives are based in spiritual principles, we find it helpful to reaffirm our decision to turn our will over to the care of the God of our understanding before making each of our amends. A Power greater than ourselves will provide us with the guidance we need.

Tradition of the Month

Tradition Nine "NA, as such, ought never be organized, but we may create service boards or committees directly responsible to those they serve."

The Ninth Tradition goes on to define the nature of the things that we can do to help NA. It says that we may create service boards or committees to serve the needs of the Fellowship. They exist solely to serve the Fellowship. This is the nature of our service structure as it has evolved and been defined in the NA service manual.

The groups' responsibility does not end with the establishment of a board or committee to fulfill their service needs; in fact, that is only the beginning. As long as the committee remains active, the groups should maintain familiarity with its affairs. The groups should also provide

continuing guidance to the committee. Our boards and committees cannot be held accountable to the groups they serve unless the groups play a responsible role in their service relationships.

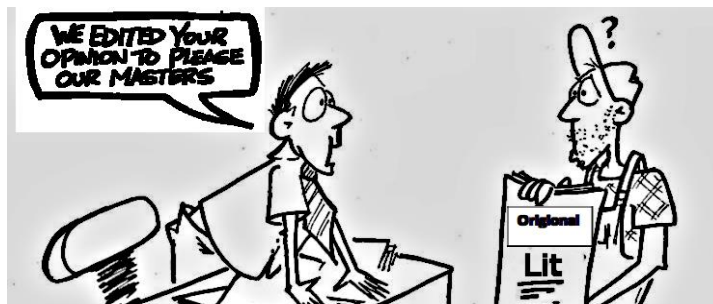

Tradition Nine cautions that while we may need assistance, we don't get to walk away after we ask for it. We balance between asking for help and ensuring that the work is done according to plan. We balance between maintaining our responsibility and allowing service boards and committees to carry out the tasks assigned to them. We give our trusted servants room to carry out their tasks, and we also keep ourselves informed enough to ensure that the work stays on course and there are enough members involved to get it done. Allowing others to have input can improve our work many times over. It takes patience and open-mindedness to be able to listen to feedback, but the process is almost always worth the time. Even if it results in no change to our practice, we gain a deeper understanding of the principals involved. Almost always, however, opening a process to input changes the result for the better.
