Outreach Committee Meeting

Initially Jeanette L. and I, Dee M. were able to go over issues related to the First Regional Convention in Cuba February 1, 2, & 3rd which we've both been working on. She has registration forms if anyone is interested in registering. There is a room for English meetings all 3 days.

We discussed that each area could identify groups that are in need of support that are geographically isolated. We would like commitments for a few members or more to attend those groups on a monthly basis. We talked of the possibility that they could get reimbursed for gas. The Unity Springs Area for example has a group, The Crescent City Group, about 45 minutes to an hour away from most of the other groups that needs our support. They are asking for people with clean time to attend. We talked of posting the groups that need support in the Newsletter, on the website, and in the minutes.

Mat from the Peace River Area stated that he is interested in starting meetings in Arcadia, a very isolated area that needs NA. We discussed different ways to make that happen. He stated that he is interested in reviving their area outreach subcommittee.

The Additional Needs Chair asked for help from groups that had people with hearing, sight and other limitations, that we approach those individuals and ask for input on how we can best serve them. For example, Jeanette has a blind person in her Homegroup and will ask them for their input to pass on to Additional Needs. We could maybe get their contact information.

Jamaica has one NA meeting in the entire country in Kingston. They meet everyday at the St. Peter and Paul School, 120 Old Hope Rd, Kingston. We talked of printing posters with the meeting address for them to put in locations, jails, churches, tourist areas,

etc. I will ask my contact in Jamaica if they are interested in this idea. We're going to look into getting their meeting on NA.org.

Connor also mentioned that there are locations where there are big Haitian communities near Ft. Lauderdale with no NA meetings. We identified other cities with the same situation.
